Allston Multimodal Project (line item 6720-2127 of H.4506) consolidated amendment summary:

- Requires maintenance of 2-track service on the Framingham/Worcester line during construction
- Requires West Station to offer local bus service within 1 year of construction commencing
- Requires 20 minute peak headway Commuter Rail service within 1 year of construction commencing
- Directs the Allston Multimodal Task Force to continue meeting throughout construction
- Requires MassDOT to develop a plan by July 1, 2021 for improved service on Framingham/Worcester line, including:
 - Additional peak trains
 - Maintenance, capital, and signal improvements
 - Third track between Framingham and Newton
 - Making all stations fully accessible
 - Addressing delays and public notification
 - Feasibility study of ticket and zone pricing changes
